# Midnight Magic!

## A Sewing and Design Challenge

Presented by  
Independent Pattern Company Alliance (IPCA)

1. VOID WHERE PROHIBITED BY LAW.

2. Contest is open to anyone 18 years old or older. Employees of IPCA members and all Sponsors, their respective parents, subsidiaries, affiliates, advertising, promotion agencies and their family members (defined as parents, spouse, children, siblings, grandparents) and/or those living in the same household are not eligible to enter.

3. To Enter:

- 1) Create a garment or outfit from the pattern collections of any IPCA member which fits the theme Midnight Magic!
- 2) Complete an official entry form. Send completed entry form with at least two photos (one of the completed garment and one close-up of any special details or techniques used) of your completed entry to the appropriate IPCA member company. Deadline: Entries must be received by January 26, 2012.

Details:

Any size garment is eligible. Garment must fit the theme, Midnight Magic! A list of participating company addresses can be found at the end of this form.

One entry per person, per pattern company, and no more than one entry per package may be submitted. Sponsors shall not be responsible for lost, late, mutilated or misdirected entries.

4. Each IPCA pattern company will choose up to 8 finalists. At that time, the garments selected for final judging will need to be sent to the appropriate member company. Fasten a copy of the entry form securely to the inside of your entry with a \$10 return shipping fee (within the continental US. All others will need to send the estimated cost of return shipping.)

You will be notified by the IPCA company by February 5, 2012, as to whether your entry will move on to the final judging.

5. The Contest will take place under the supervision of the Sponsors. There will be two types of winners.

(1). Each pattern company will award a "People's Choice Award" of a \$100 Gift Certificate. Voting will take place at the Sewing and Stitchery Expo in Puyallup, Washington March 1-4, 2012. Note: The People's Choice award winner is eligible for the Grand Prize, Second and Third Prizes.

(2). The Grand Prize, Second and Third Prizes will be determined and awarded on March 19-21, 2012 at the International Textile Expo in Las Vegas, NV.

After that date all entries and prizes will be mailed to contestants accordingly.

6. Sponsors reserve the right to disqualify any entry that is believed to contain obscene, offensive, or inappropriate content or that does not comply with the official rules or theme.

7. Sponsors make no warranties with regard to the prizes. Prizes are not transferable. No prize substitution is allowed by the winner, but Sponsors reserve the right to substitute a prize of equal or greater value due to prize unavailability. Prizes are not redeemable by winner for cash value.

8. Prize winners residing in countries other than the United States will be responsible for any duty or customs fee associated with shipment of the prize.

9. Sponsors have the right to photograph and use images of all entries. Entry constitutes permission to use the winner's name, picture, likeness, and city and state of residence for purposes of trade, publicity or promotion for no additional compensation except where prohibited by law. All entries must be original, may not have won previous prizes and must not infringe on any third party rights. Submission of an entry constitutes entrant's consent (or that of their parent/legal guardian should they be a minor in their state of residence) to irrevocably assign to Sponsors any and all rights to their entry including, but not limited to, intellectual property rights. Submission of an entry grants Sponsors and their agents the right to publish, produce, use, adapt, edit and/or modify the entry in any way and in any and all media, without limitation and without compensation to the entrant.

10. The winner (or their parent/legal guardian should they be a minor in their state of residence) may be required to execute an Affidavit of Eligibility, a Liability Release and where lawful a Publicity Release. All taxes on prizes are solely the responsibility of the winners.

11. All entrants release the Sponsors, their affiliates, parents, subsidiaries, directors, officers, employees, and agents, and all others associated with the development and execution of this from any and all liability from injury, loss or damage of any kind resulting from participation in this promotion or acceptance or use of any prize.
